  - Firefighter Protective Clothing including Helmet, Hood, Coat, Bunker Pants with Boots and Gloves
  - Clothing appropriate for anticipated weather conditions (winter clothing, rain gear, etc...)

**RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK AND INDEMNITY**

1.
