Weekly Road Construction Update



Week of August 5th 2024

The following are the planned major work activities by Town of Holden Departments. The work schedule is subject to change based upon weather and other factors. Activities may be added or subtracted dependent on those factors. Neighborhoods directly impacted by the planned work will be separately notified by the Town's CodeRED system, and updates may be found on the Town's Facebook page. Department of Public Works

Highway Division

• There are no planned road closures for the week of August 5th.

Water & Sewer Division

• Water & Sewer Division has no planned closures for the week of August 5th.

Light Department

Line Division

• On Thursday, August 8th, Holden Street will be closed between Shrewsbury Street and Marlen Road. Crews will still be working in this area on Friday, August 9th, but the street will remain open with the assistance of traffic control details.

Forestry Division

- Various locations but no road closures are currently scheduled.
- GML contracted tree crews will be on upper Malden Street at the beginning of the week and Salisbury Street all week with traffic control details. No road closures are expected.

Known Outside Agency and Private Work

MassDOT (Main Street, Route 122A)

• The grinding of the roadway surface is complete. Adjustments to manholes and catch basins will take several weeks. Work will continue on sidewalks.

MassDOT (Shrewsbury Street-Doyle Road-Chapel Street-Holden Street Project)

- Work is ongoing on Wachusett Street between Lincoln Avenue and Shrewsbury Street, resulting in a detour to Lincoln Avenue.
- Beginning on Monday, August 5th, E.H. Perkins' drainage crew will return to Holden Street between Shrewsbury Street and Marlen Road. Holden Street will be closed in the southbound direction, northbound should remain open. Southbound traffic will be detoured via Homestead Road and Marlen Road until Wednesday or Thursday.
- Beginning on Wednesday, August 7th or Thursday, August 8th, E.H. Perkins' drainage crew will relocate to Chapel Street. Chapel Street traffic will be detoured via Red Barn Road and Tyler Drive.

Eversource Gas (Shrewsbury Street)

- The contractor for Eversource Gas will be working on Shewsbury Street at Wachusett Street with traffic control details.
- On Tuesday, August 6th, the crew will be working on Marlen Road near Holden Street. Marlen Road will maintain one lane eastbound towards Holden Street.
- The crew will also be working at the corner of Chapel and Shrewsbury Street later in the week, restricting the right turn lane from Chapel Street to Shrewsbury Street.
