## Weekly Road Construction Update



### Week of August 19<sup>th</sup> 2024

The following are the planned major work activities by Town of Holden Departments. The work schedule is subject to change based upon weather and other factors. Activities may be added or subtracted dependent on those factors. Neighborhoods directly impacted by the planned work will be separately notified by the Town's CodeRED system, and updates may be found on the Town's Facebook page. #### Department of Public Works

##### Highway Division

- On Tuesday, August 20<sup>th</sup> and Wednesday, August 21<sup>st</sup>, the Highway Division will be working on Quinapoxet St near the RR crossing. Traffic will be detoured via Main St and Rt 31.

##### Water & Sewer Division

- Water & Sewer Division has no planned closures for the week of August 19<sup>th</sup>.

#### Light Department

##### Line Division

- On Wednesday, August 21<sup>st</sup>, crews will be working on Wachusett Street at Manning Street with the assistance of traffic control details.
- For the remainder of the week, line crews will be working various locations within MassDOT projects.

##### Forestry Division

- Tree crews will be on Salisbury Street all week with traffic control details.
- Various other locations but no road closures are currently scheduled.

## **Known Outside Agency and Private Work**

### **MassDOT (Main Street, Route 122A)**

- Adjustments to manholes and catch basins will continue through the end of August. Work will continue on sidewalks. Lane shifts around the work zones is to be expected.
- Leveling and grading of Main Street and side street approaches will continue through the end of August. Top course paving is expected to begin early/mid-September.

### **MassDOT (Shrewsbury Street-Doyle Road-Chapel Street-Holden Street Project)**

- Wachusett Street remains closed between Lincoln Avenue and Shrewsbury Street, resulting in a detour to Lincoln Avenue.
- E.H. Perkins' drainage crew will continue to work at the intersection of Holden Street and Shrewsbury Street. Holden Street will be closed in the southbound direction, northbound should remain open. Southbound traffic will be detoured via Homestead Road and Marlen Road.
- Installation of new traffic signal conduit in the intersection of Shrewsbury Street, Holden Street, and Chapel Street may result in a Chapel Street closure and detour through Red Barn Road and Tyler Drive.

### **Eversource Gas (Shrewsbury Street)**

- Monday, August 19<sup>th</sup> through Thursday, August 22<sup>nd</sup>, R.J. Devereaux, the contractor for Eversource Gas, will be working overnight (7:30 pm to 5:30 am) at the intersection of Main Street and Shrewsbury Street.
